

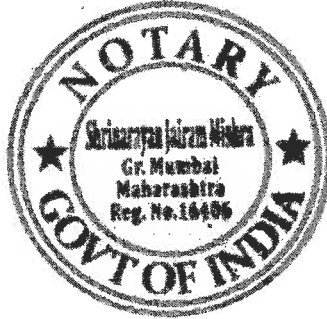

AGREEMENT OF FAMILY SETTLEMENT

This Agreement of Family Settlement executed at Thane City, Maharashtra, this 9th day of March in the Christian Year of 2020;

BETWEEN

SHRI ARVIND KAMATH S/o, SHRI LAKSHMINARAYAN KAMATH [PAN: ACGPK7456C] [AADHAR: 454861482155], aged about 50 years of Thane, Indian Inhabitant, presently residing at Flat No. 2004, Fiona, Hiranandani Estate, Ghodbunder Road, Thane (West) - 400 607, hereinafter referred to as 'the Husband' of the Party of One Part;

AND

SMT. PRAJWAL KAMATH wife of SHRI ARVIND KAMATH [PAN: AIUPK5845K] [AADHAR: 984455818752]. aged about 43 years of Thane, Indian Inhabitant, residing at Flat No. 2004, Fiona, Hiranandani Estate, Ghodbunder Road, Thane (West) – 400607, hereinafter referred to as 'the Wife' of the Party of Other Part;

WHEREAS:

- (I) The Party of One Part is the husband of the Party of Other Part and they both got married on or about 03/12/1998 at Mumbai as per Hindu Rites and are still professing and governed by Hindu Vedic Rites, Tradition and Law and have been jointly residing in Flat No. 2004, Fiona, Hiranandani Estate. G. B. Road. Thane (West) – 400 607;
- (II) Out of the said wedlock, the Parties hereto have a Son born on 30/3/2002 at Thane and christened / named as 'Tanishk Kamath' (hereinafter referred to as 'the Son') who is presently studying in 12th standard Science;
- (III) Both the parties are educated and, over a period of time, have developed several businesses (hereinafter referred to as 'Family Businesses') which includes the following Companies (which shall hereinafter be referred to as 'Family Companies'):
- Mascot Capital & Marketing Pvt. Ltd. (Holding Company) ('MCMPL' – for short);
 - Mascot Dynamics Pvt. Ltd. ('MDPL' – for short);
 - JNK India Pvt. Ltd. ('JNK' – for short);
 - Porvair Filtration India Pvt. Ltd.;
 - Chetra Seals Pvt. Ltd.;
 - Prakalp Energy Vertical Pvt. Ltd.
- (IV) Both the parties, over a period of time, have purchased and acquired several moveable and immovable properties and also made investments

in their respective single name and also in joint names (hereinafter collectively referred to as '**the said Assets**');

- (V) Due to some disputes & differences having arisen between the parties hereto, both the Parties hereto have mutually resolved the said disputes and have further identified all the movable and immovable properties belonging to both of them, either jointly or in their single name, and have distributed the said movable and immovable properties between them upon the terms and conditions hereinafter recorded.

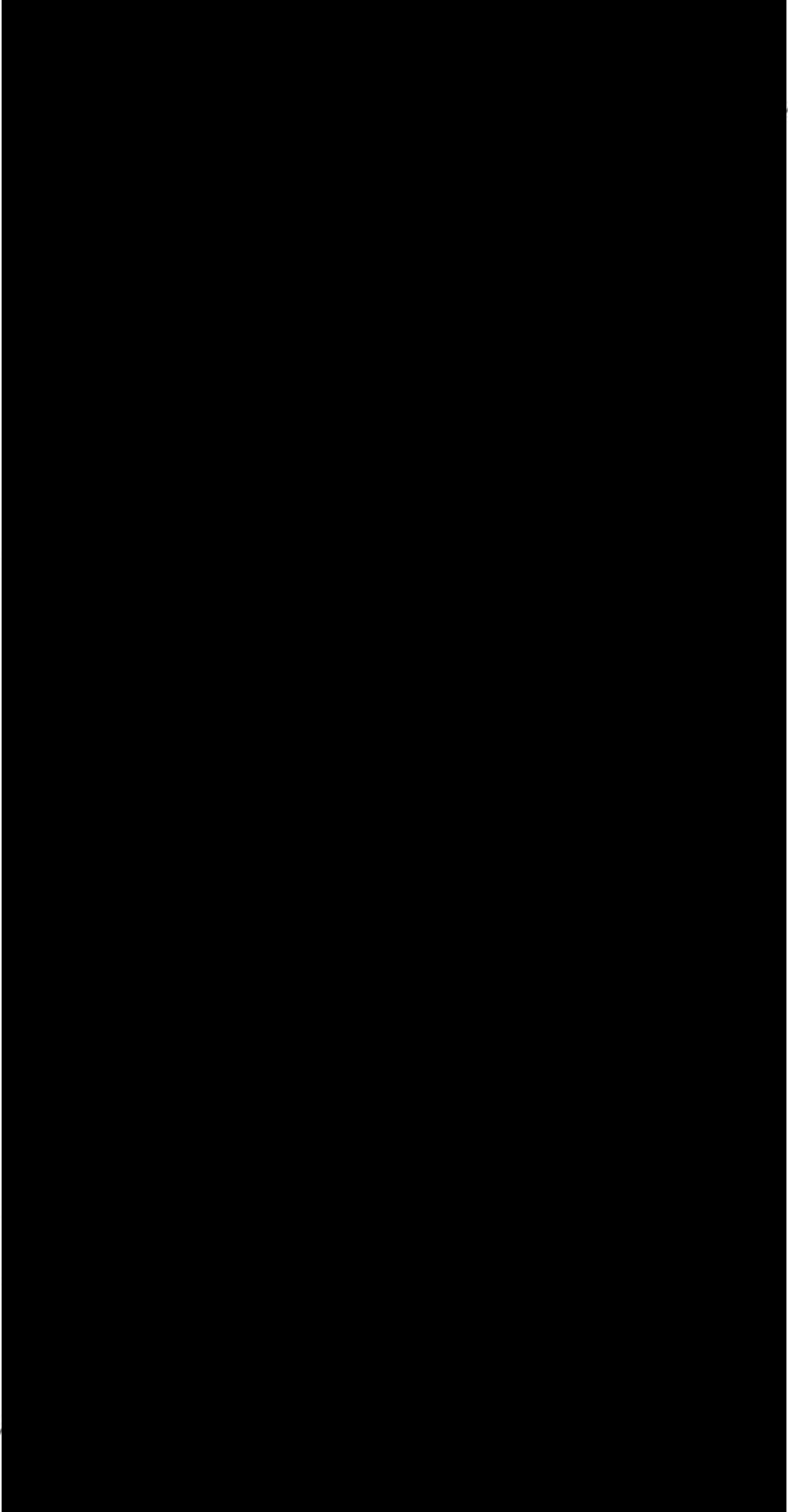
NOW, THEREFORE, THIS AGREEMENT WITNESSETH AS UNDER:

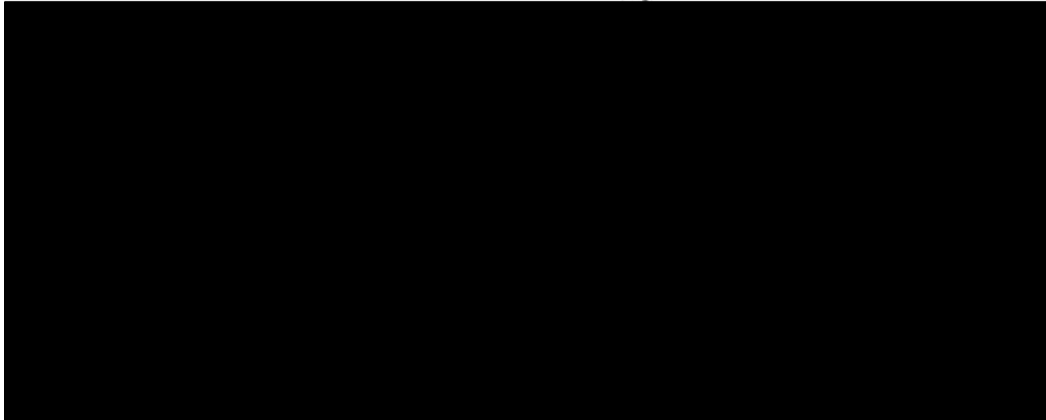
1. The Recitals mentioned hereinabove shall form integral part and parcel of these presents and shall be deemed to have been incorporated here.
2. In terms of the said mutual Agreement, being again duly reiterated and confirmed by the Husband, the following investments and properties, movable as well as immovable, (hereinafter collectively shall be referred to as '**the assets of Wife**') shall remain and/or be exclusively vested with and/or be transferred, as the case may be, to the Wife with her complete, absolute, full, unencumbered right, title, interest, possession, domain and ownership thereof:

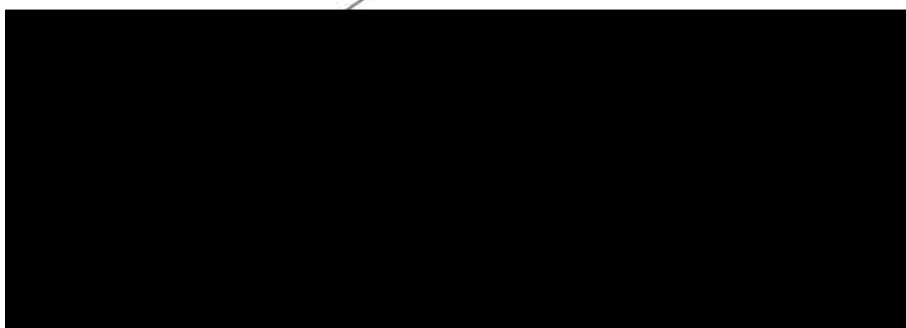
3. In terms of the said mutual Agreement, being again duly reiterated and confirmed by the Wife, the following investments and properties, movable as well as immovable, (hereinafter collectively shall be referred to as 'the assets of Husband') shall remain and/or be exclusively vested with and/or be transferred, as the case may be, to the Husband, however, subject to clause 4 hereinbelow, with the complete, full, unencumbered Right, Title, Possession, Domain and Ownership of the Husband:

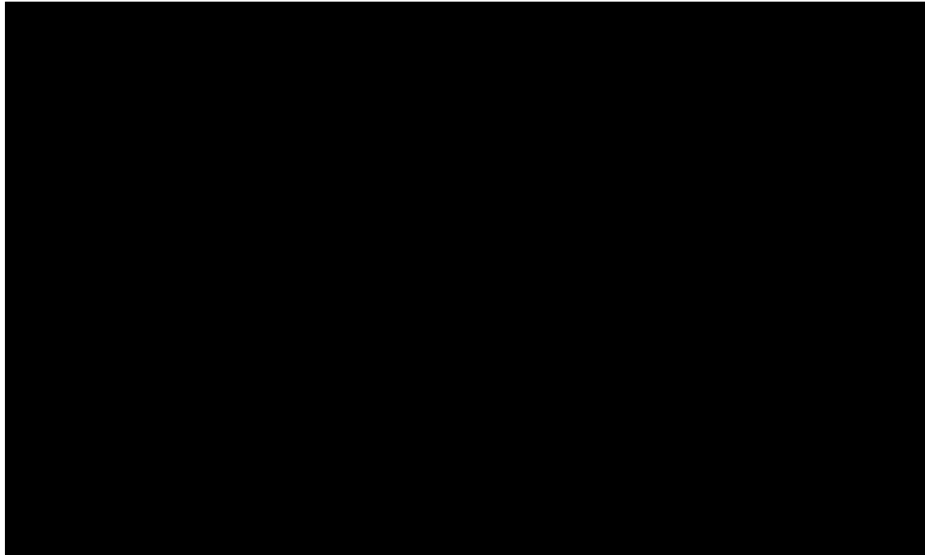

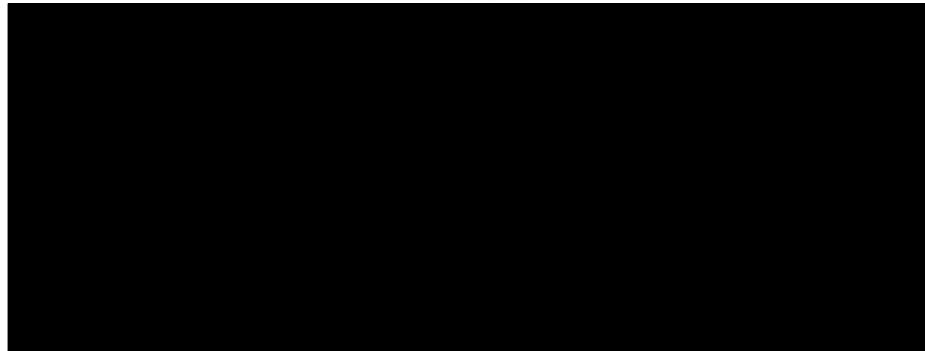

3.2.3. All the businesses will be owned by Husband and the Wife shall relinquishes all her rights over all the businesses subject to compliance by the Husband of relevant terms and conditions as set out in Clauses 6 & 8 including all sub-clauses therein.



Swapping of the Ahmedabad properties with Husband's Fixed Deposits:

- 4.1. The Husband represents that the present aggregate sale value of the Ahmedabad properties, referred in clause 2.1.3 above r/w. Second Schedule hereunder written ('the Ahmedabad Properties'), is 
- 4.2. The Husband agrees and undertakes to sell the said Ahmedabad properties within 3 months from execution of these presents and

to pay the sale consideration thereof to the Wife, or in lieu thereof pay to the Wife equivalent amount thereof, provided however that if sale consideration realised from the sale of the said Ahmedabad properties is less than [REDACTED] then in that event, the Husband shall make good the deficit / shortfall amount by paying the shortfall thereof to the Wife and if the sale consideration is more than [REDACTED] Wife shall be entitled only [REDACTED] and the excess, if any, therefrom may be appropriated by the Husband.

- 4.3. It is further agreed and undertaken by the Husband that in the event, the Husband is unable to sell all the Ahmedabad properties or any part thereof within said stipulated time, then in that event, the Husband shall, if none of the Ahmedabad properties is sold, transfer in the name of Wife the specified Fixed Deposits, the details whereof are set out in Fourth Schedule hereunder written, or in lieu thereof pay to the Wife equivalent amount thereof, and if few properties are sold and consideration thereof is paid to Wife, then in that event the Husband shall, out of the said Fourth Schedule mentioned Fixed Deposits, transfer in the name of Wife, such numbers of Fixed Deposits so as to cover-up the shortfall of the total realisation value of [REDACTED] to the Wife from the Ahmedabad properties, or in lieu thereof pay to the Wife equivalent shortfall amount thereof, and before effecting such transfer of the Fixed Deposits in the name of Wife, the Husband undertakes to remove and clear off the existing lien thereon.
- 4.4. It is further agreed and declared that till the compliance with respect to the above Ahmedabad properties, as set out in sub-clause 4.3 hereinabove, is completely complied with by the Husband, the said Fourth Schedule mentioned Fixed Deposits shall stand charged as a security for ensuring the transaction as mentioned hereinabove.

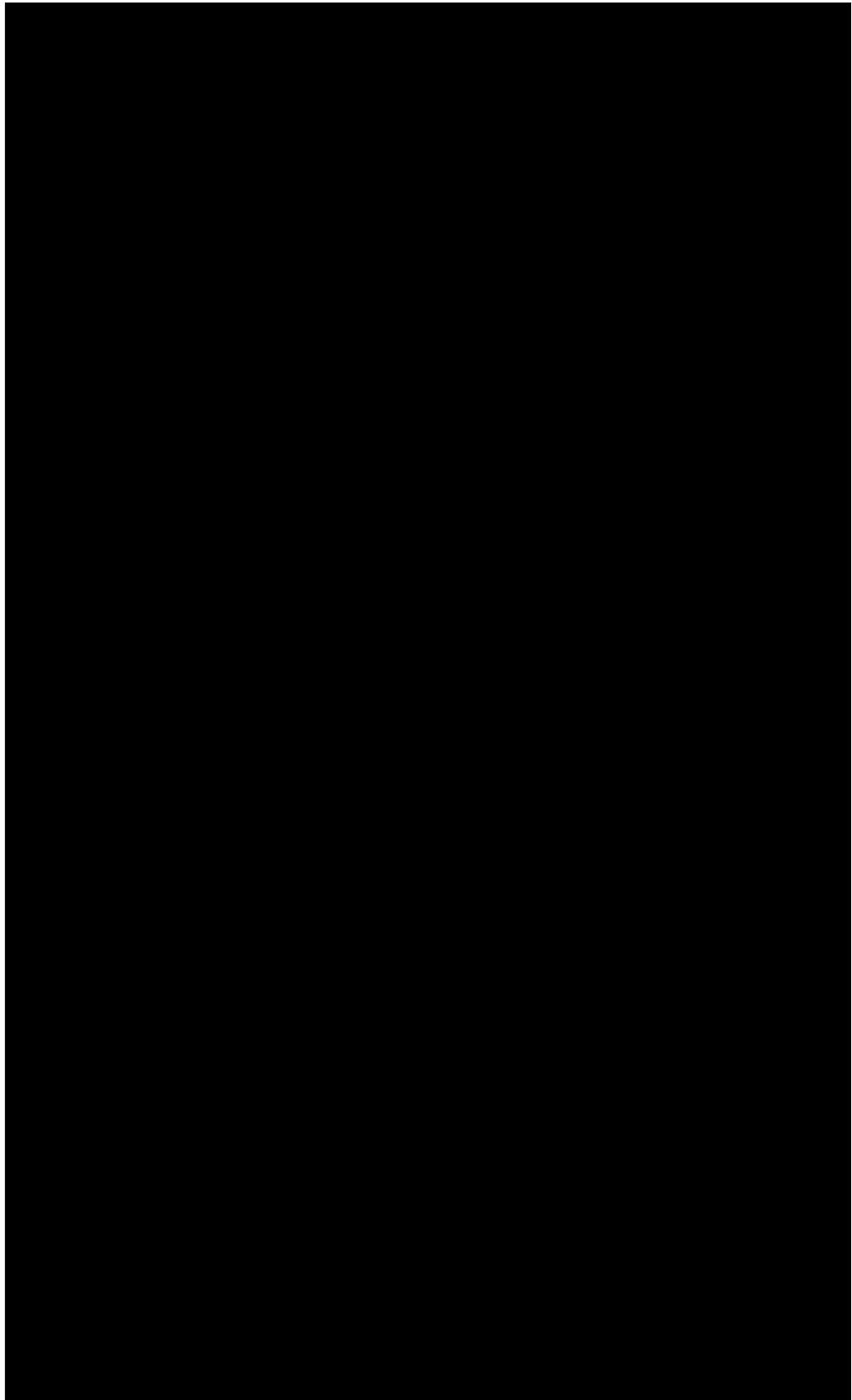

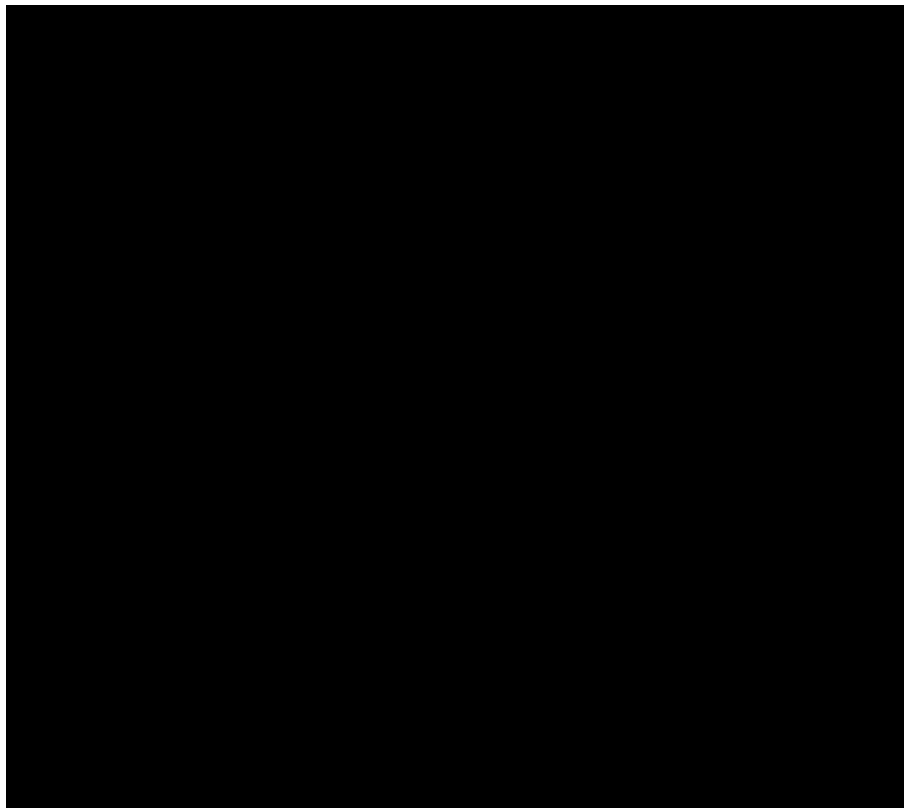




5. Loans Adjustments:

In consideration of overall settlement between the parties, the loans, as set out in clauses 5.1.1 and 5.1.2, shall be adjusted in the manner as set out in clauses 5.2, 5.3, and 5.4 hereinafter:

6. Within a period of 2 months from the execution of this Agreement, the Husband has agreed:
- 6.1. to pay Wife a remuneration of [REDACTED] [REDACTED] towards various services provided by Wife to the Family Companies for the F.Y. 2018-19;
- 6.2. to deposit a sum of [REDACTED] towards the Corpus Fund in the designated Bank Account as stated in clause 13.2. hereinafter for welfare of the Son.
7. After execution and Notarisation of this Agreement, the Wife agrees to comply with all the formalities of the banks with regard to the renewal of the existing financial facilities to be provided to any of the said family companies. The Wife shall also comply with all the legal formalities with respect to Family companies.
8. The Husband specifically agrees and undertakes to do the following acts, deeds, things and performance strictly within 3 months from the date of execution of these presents:



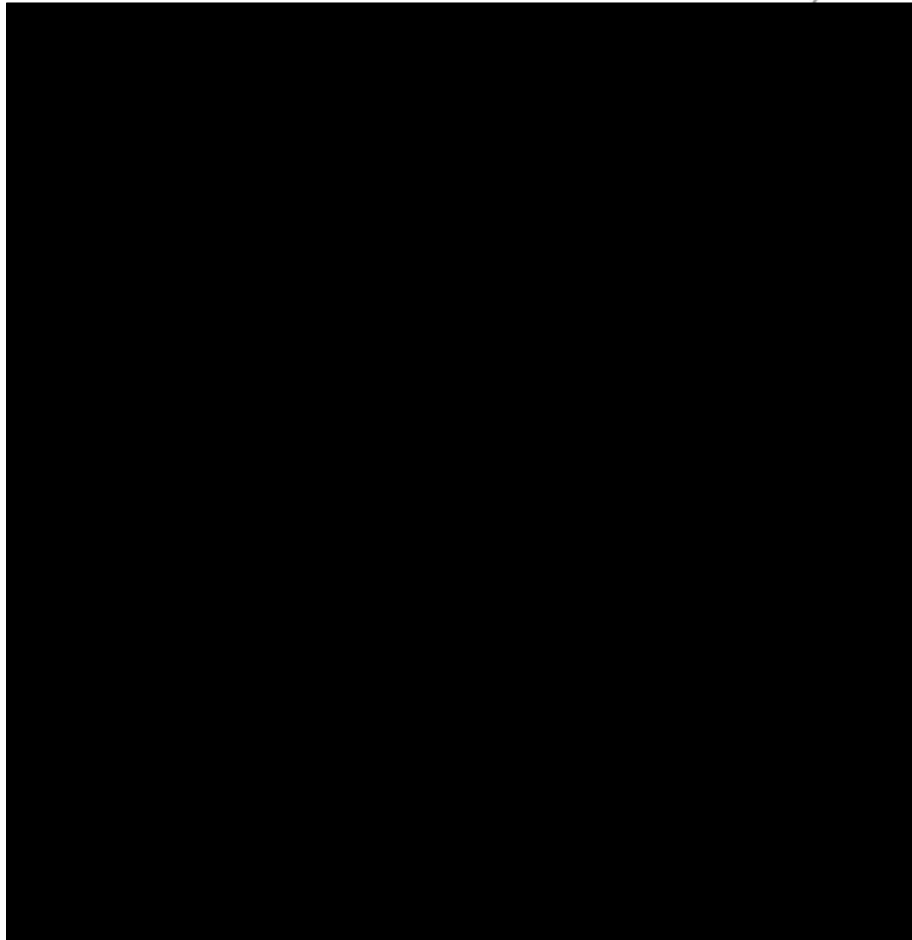

- 8.3. To execute and register the Release Deed / Gift Deed thereby unconditionally releasing / gifting, as the case may be, in favour of the Wife all the right, title and interest of the Husband, as the joint owners, in the following immovable properties:

At his own cost, charges and expenses, to execute proper documents for transferring and / or relinquishing in favour of the Wife all his right and interest in the following Fixed Deposits presently standing in the joint names and to get the name of the Husband removed as the joint owner from, in or with respect to the following Fixed Deposits:

8.4.1. Subject to clause 4 hereinabove, to transfer the Fixed deposits set out in Fourth Schedule hereunder written.

8.5. To pay or cause to be paid by Team Aqua Technologies Pvt. Ltd. a sum of [REDACTED] towards salary of the Wife in Team Aqua Technologies Pvt. Ltd.

8.6. To pay to cause to be paid by Paresh Steel Traders [REDACTED] being the principle amount and the interest thereon.

9. Within 30 (Thirty) days from the completion of all the responsibilities as set out in clauses 6 and 8 including sub-clauses therein, the Wife, at the cost and expenses of the Husband, agrees to do following acts, deeds, things and performance:

complete compliance and formalities by the Husband of all the requisitions set out in clauses 6 & 8 hereinabove and in addition thereto upon the Husband arranging the discharge of the Wife from all the guarantees, indemnities, undertakings or any other liability of whatsoever nature obtained from the Wife for securing any financial assistance or facility granted / extended or enhanced by any Bank or Financial Institutions to any of the family companies or joint venture family companies (collectively referred to as 'the Bank liabilities').

- 10.2. The Husband has informed the Wife that, as per the banking procedures and norms, so long as the Wife holds said equity shares in MCMPL, the banks / financial institutions cannot discharge the Wife from the said Bank liabilities.
- 10.3. The parties have, therefore, to ensure their respective security, agreed for a mechanism / scheme for ensuring discharge of the Wife from the said Bank liabilities and transfer of the shares as stated hereinafter.
- 10.4. Upon compliance of all the requisitions as set out in clauses 5.2 r/w. 5.3, 6, 8 hereinabove by the Husband, the Wife shall complete all the formalities related to the transfer of her 80% shareholding in MCMPL to Husband which shall be transferred to the Husband and accordingly the endorsement of such transfer to the Husband shall be made on the same day of the execution of the transfer forms.
- 10.5. Such duly 80% transferred shares of MCMPL alongwith duly completely stamp-duty paid Transfer Forms in favour of the Wife (collectively referred to as '**the said Shares & Transfer documents**') shall be executed and delivered by the Husband, with written advance communication to the Wife, in Escrow to Chartered Accountant Mr. Kishor P. Chaudhari (Cell No.9820068717) ('the Escrow Agent' – for short), being a

Partner in CVK & Associates, a Chartered Accountant Firm, having office at 2, Samarth Apartments, D. S. Babrekar Road, Dadar (West), Mumbai – 400 028, Landline Telephone No. 022-24451488, 022-24468717, Email: kpc@cvk-ca.com. The Escrow Agent is recommended by the Husband and the Wife has accepted the recommendation. The Husband has informed the Wife that the Escrow Agent has given his consent to act as the Escrow Agent for the purpose and upon the terms and conditions as within mentioned.

- 10.6. The Escrow Agent shall keep deposited with him in Trust, the said Shares and Transfer documents and shall deal with the same in the manner as set out in sub-clauses 10.7, 10.8 & 10.9 hereinafter.
- 10.7. Within 75 days from the transfer of the said 80% shares of MCMPPL in the name of the Husband, the Husband shall expeditiously and on top priority complete all the formalities with regard to discharge of the Wife from the said Banks of all her liabilities relating to, or with regard to or arising out of any financial assistance / facilities extended by such Bank to any of the family companies in every respect. The said period of 75 days may, however, be further extended by a grace period of 15 days on the reasonable and justified grounds.
- 10.8. If the Husband completes all the formalities as provided for in clause 10.7 above, the Escrow Agent shall handover to the Husband the said Shares & Transfer documents.
- 10.9. If the Husband fails to complete all the formalities as provided for in clause 10.7 above, the Escrow Agent shall handover to the Wife the said Shares & Transfer documents.
- 10.10. If the events as set out in clause 10.9 happens, the Wife shall submit the said original shares alongwith the said Transfer

documents to MCMPL and upon such submission the said 80% shares of MCMPL shall, immediately be transferred and endorsed in the name of the Wife and such endorsed share certificates delivered to the Wife on same day of submission.

10.11. It is clarified that the Husband and Wife are the only two Directors in MCMPL, therefore, for the purpose of effecting the transfer of shares as envisaged in clause 10.10. hereinabove, the Husband unconditionally and irrevocably hereby consents for the retransfer of the said shares of MCMPL in the name of the Wife as envisaged in clause 10.10 above and further undertakes not to create any hurdle, objection, hindrance of any nature whatsoever for the same.

10.12. The Husband shall be liable to bear and pay the fees and other expenses of the said Escrow Agent.

11. Any Income Tax related cases in the name of wife with regard to Family companies and proprietorship company upto Year ending 31/03/2018 shall be handled by Chartered Account Mr. Shantilal Jain and assisted by the Husband and the penalty or charges, if any, levied by the Income Tax Authority shall be borne and paid equally by Wife and Husband.

12. Any outstanding receipts or excess taxes paid in respect of Mascot International will be divided equally after deducting the tax. New Invoices raised in this company in future the amount received will also be divided equally for the businesses already carried out. No new business will be carried out in Mascot International.

13. **Provision for the welfare of the Son:**

13.1. The Parties have mutually decided to arrange a Cash Corpus fund of [REDACTED] to be equally contributed by the Husband and the Wife towards the provision for the welfare of the Son. The said Cash Corpus of [REDACTED] shall be deposited in Axis Bank

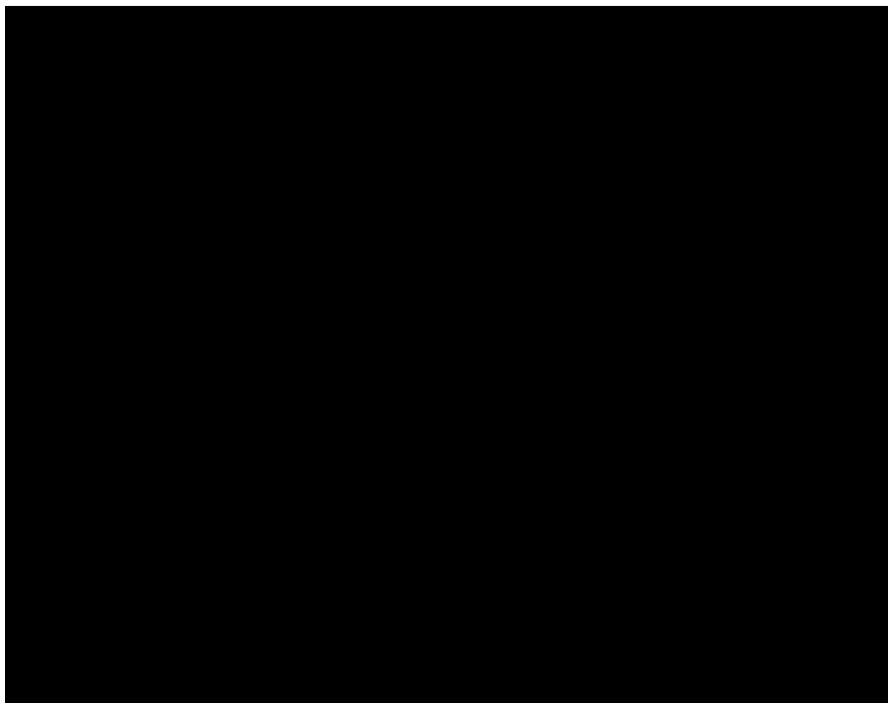

[REDACTED] to be operated jointly by the Wife and Son. Provided however that the Wife, with consent of the Son, may open a new Corpus Account in any other Bank and the Corpus fund lying deposited in the said Designated Account with Axis Bank may also be transferred to such new Corpus Account.

- 13.2. Towards the said Corpus Fund, each of the parties hereto shall, within a period of 2 months from the date of execution hereof, deposit a sum of [REDACTED] in the said Corpus Account.
- 13.3. Thereafter, each of the parties shall deposit a sum of [REDACTED] within First Quarter of every financial year commencing from Financial Year 2020-21 in the said Corpus Account for a period of 7 years.
- 13.4. It is specifically agreed that the Wife shall be custodian of the said Corpus Fund Amount and shall have absolute authority to invest part or substantial part of the said Corpus Fund in Fixed Deposits or other investments avenues so as to earn better returns / benefits.
- 13.5. The Husband hereby unconditionally creates charge on the said Agricultural Land alongwith Farmhouse thereon situated in Village – Chandap, Taluka, Ambernath, District – Thane, Maharashtra, more particularly described in the Third Schedule hereunder written, to secure his liability for his contribution in the Corpus Account or any part thereof.
- 14.1. The various commercial premises of the Wife have been given on Leave & License to various Family Companies at the license fee as set out in detail as follows:

14.2. The Husband undertakes to pay, without default and demand, the License Fees of the aforesaid Licensed premises as per their respective Leave & License Agreements or ensure the payment thereof made by the respective Licensees. It is, however, specifically agreed and declared that any outstanding payment of the Licensee fee or any other payments in respect of the aforesaid Leave & License in terms of their respective Leave & License Agreement shall always remain to be the personal liability of the Husband if such payments are not made by the respective Licensees on demand.

15. **Time is the Essence:**

Both the parties agree that in respect of obligations undertaken by each of them under this Agreement, time is the essence.

16. After the transfer of shares and resignation of directorship of the Wife from all the Companies, the Husband hereby unconditionally agrees and undertakes to indemnify the Wife and keep the Wife fully and completely indemnified from and against any claim, demand, payment, liability, litigation, costs, charges, expenses, etc. of any nature whatsoever arising out of the following to which the Wife may be subjected to or made to suffer:

- 16.1. Any business, commercial or administrative action or affairs of the family companies or Joint venture family companies;
- 16.2. Any financial assistance or transactions, of whatsoever nature, entered into or effected by or availed by any of the said family companies or any joint venture companies;
- 16.3. Any liability or responsibility arising out of timely non-compliance of a statutory obligations applicable on the said family companies or any of the joint venture companies;
- 16.4. Failure to timely comply with the statutory obligations pertaining to the office staff, as may be prescribed under any statute including the Labour Legislation and Labour Welfare Legislation;
- 16.5. Any other circumstances whatsoever.
17. The Husband agrees and undertakes to vacate and leave the [REDACTED] [REDACTED] simultaneous with the execution of these presents, so as to entitle the Wife for the exclusive possession of the said Flat.

18. Arbitration:

The parties hereto agree that all the disputes arising upon, over or in respect of any of the terms of this Agreement including interpretation or enforcement thereof, the same shall be referred to a Sole Arbitration of a Retired High Court Judge, if mutually agreed to, or appointed by the Hon'ble Bombay High Court in terms of Arbitration & Conciliation Act, 1996. The place of Arbitration will be at Mumbai / Thane and the language thereof shall be English. The Award passed by the Arbitrator shall be final and binding upon the Parties. The parties shall make sincere endeavour to complete the Arbitration proceeding within a period of Six months.

19. **Severability:**

If any provision of this Agreement is invalid or unenforceable or prohibited by Law, this Agreement shall be considered divisible as to such provision and such provision shall be inoperative and shall not be part of the consideration moving from either party to the other and the remainder of this Agreement shall be valid and binding and of like effect as though such provision was not included herein.

20. **Waiver:**

Each party agrees that any delay or omission on the part of the other party to exercise any right under this Agreement will not automatically operate as a waiver of such right or any other right and waiver of any right by the other party hereunder on one occasion will not be construed as a bar to a waiver of any right on any occasion.

21. **Modification:**

No change, modification or variation whatsoever in terms and conditions of this Agreement or any waiver thereof shall be deemed to have taken place unless the same has been mutually agreed to and duly signed by both the Parties.

22. **General:**

22.1. All notices which are required to be given hereunder shall be in writing and shall be sent to the address of the recipient set out in this Agreement or such other address as the parties may notify each other and the same shall be sent only by Registered Post With Acknowledgement Due (RPAD) or Speed Post with the name and address of the other party properly and legibly written and by NO OTHER MODE. Any such communication shall be deemed to have been served only when the same is received by the Address. There shall be deemed acceptance of the communication in case of refusal / evasion of service of the communication.

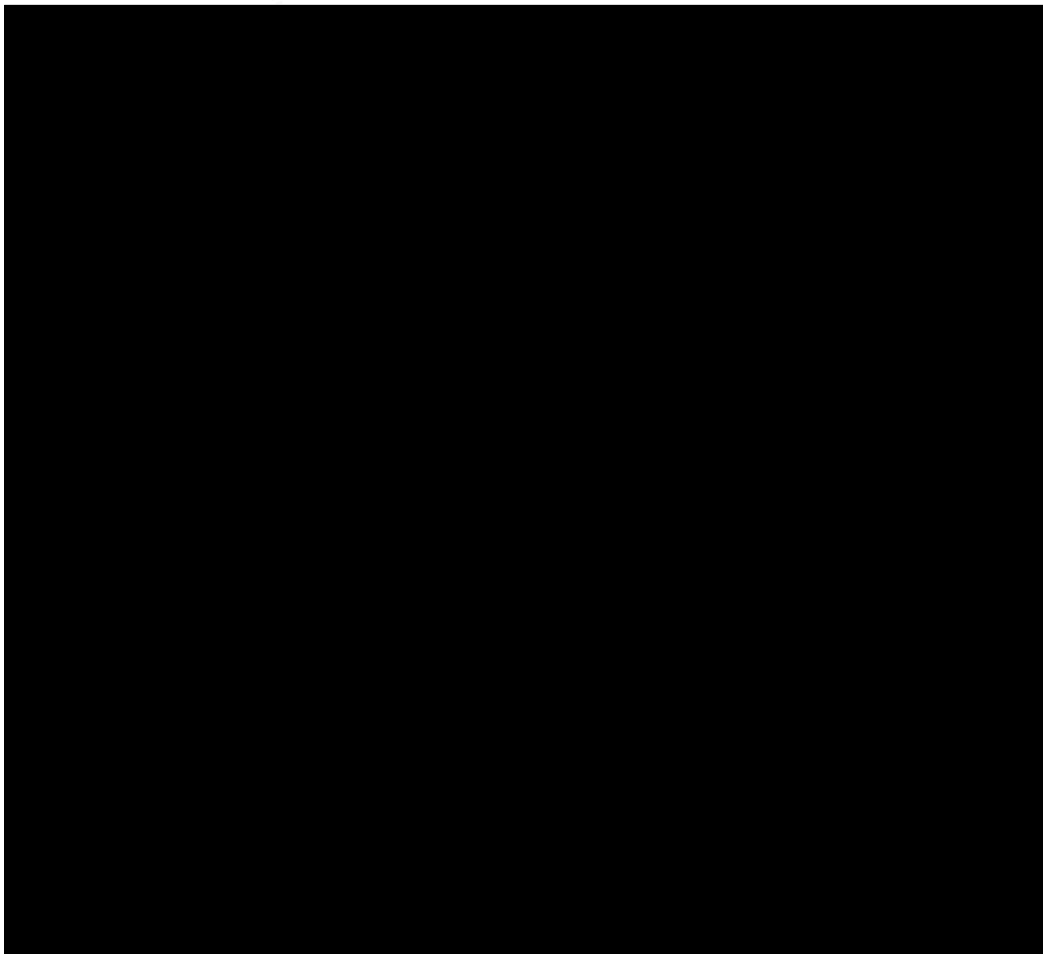
